THE EIGHT OTHER BOARD MEMBERS INCLUDE EXPERTS--LEADERS IN THEIR FIELDS-- WHO WORK TOGETHER TO FULFILL THE TBWP MISSION AND ENSURE THAT THE TBWP MEETS THE HIGHEST STANDARDS OF NON-GOVERNMENTAL ORGANIZATION EFFECTIVENESS AND
